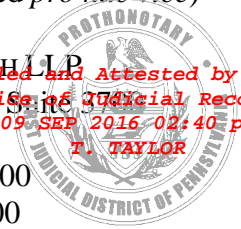

NOTICE OF APPEAL

Notice is hereby given that Defendants Janssen Pharmaceuticals, Inc.; Johnson & Johnson; and Janssen Research & Development, LLC, appeal to the Superior Court of Pennsylvania from the entry of Judgment in the above-captioned case on September 8, 2016, which made final the Orders of the Court of Common Pleas entered on the docket in the above-captioned case (a) on July 25, 2016, denying Defendants Janssen Pharmaceuticals, Inc., Johnson & Johnson, and Janssen Research & Development, LLC's Motion for Post-Trial Relief Pursuant to Pa. R.C.P. No. 227.1 and the pretrial orders cited therein; (b) on August 10, 2016,
